Applications must be signed by the registered voter and delivered to the Oneida Public Library, 459 Main Street, Oneida, NY 13421 not later than 5:00 p.m. the day before the Library Vote or postmarked not later than seven (7) days before the Library Vote.

Oneida Public Library Special Library District Absentee Ballot Application

Who is eligible for an absentee ballot?

Any registered voter residing in the Oneida Public Library Special District, which is co-extensive with the Oneida City School District, who will be out of the Library District on the day of the Library Vote or who is ill or disabled may apply for an absentee ballot. Persons who are ill or disabled on a long-term or permanent basis may apply for a “permanent absentee ballot” and receive a ballot for each Library Vote without further application.

Specifically, a registered voter can apply for an absentee ballot for one of the following reasons:

1. You will be out of the Library District the day of the Library Vote because of vacation, work, or school;
2. You are temporarily ill or disabled;
3. You are the primary caregiver for ill or disabled person(s);
4. You are detained in jail awaiting action by a grand jury or a trial or are confined in jail after conviction for an offense other than a felony;
5. You are a patient in a Veterans Administration hospital; or
6. You have a permanent illness or disability.

How does an absentee ballot work?

Your absentee ballot is a paper ballot that looks exactly the same as the official ballot. It is a secret ballot.

To obtain an absentee ballot:

1. You must first fill out and sign the Special Library District Absentee Ballot Application. You or your designated representative can request an application from the Library Director either in person Monday through Friday, 9:00 a.m. to 5:00 p.m., at the Oneida Public Library, 459 Main Street, Oneida, NY 13421, or by mail to the same address. The application is also available on line at www.midYork.org/oneida.
2. You must return the application either (a) by mailing it to the Director of the Oneida Public Library no later than seven days before the day of the Library Vote or (b) by delivering it or directing your designated representative to deliver it to the Director at the Library Monday through Friday, 9:00 a.m. to 5:00 p.m., no later than the day before the Library Vote.
3. Upon receipt of your application by mail, the Library Director will mail to the designated address an official ballot along with an official return envelope. If the application is hand-delivered, the applicant can receive at that time the official ballot and envelope.
4. Completed ballots must be sealed within the official envelope provided and the envelope signed on the back beneath the oath and dated. Ballot envelopes that are mailed must be postmarked no later than the day before the Library Vote. Those delivered by hand should be submitted to the Library Director at the Library Monday through Friday, 9:00 a.m. to 5:00 p.m., or on the day of the Library Vote 9:00 a.m. to 9:00 p.m.
